### RESPONSE TO STRAITS TIMES ARTICLE OF 10 APRIL 2020

---

The Board of Directors (the “**Board**”) of HC Surgical Specialists Limited (the “**Company**” and together with its subsidiaries, the “**Group**”) refers to the Straits Times article of 10 April 2020 “Surgeon loses defamation suit as judge upholds woman’s claim that he took advantage of vulnerable patients”.

The Straits Times article relates to a defamation suit (the “**Suit**”) taken out by the Group’s specialist surgeon, Dr Julian Ong, against a woman who filed a complaint against him and psychiatrist Dr Chan Heng Nieng, who does not work in the Group, to the Singapore Medical Council (“**SMC**”) that they had both colluded to take advantage of vulnerable female patients “to satisfy their immoral desires”. Dr Julian Ong’s defamation action was dismissed with costs on 3 April 2020 and he is solely responsible for the costs in connection with the Suit.

The Board would like to highlight that the Company does not approve of the matters alluded to in the Suit. Given that the Company understands that the SMC’s Complaints Committee is in the process of determining the complaint, and the facts of the matter presented in the Suit relates only to the defamation action, the Board will await the decision of the SMC’s Complaints Committee before determining if any further action will be necessitated.

In the interim, the Group has reviewed the matters alluded to in the Suit and has stressed upon Dr Julian Ong of his obligations under the SMC’s Ethical Code and Ethical Guidelines.

Consequently, the Company has further reminded and stressed upon all its doctors of their obligations under the SMC’s Ethical Code and Ethical Guidelines, in particular, to maintain propriety and observe appropriate boundaries in their relationship with patients as well as to maintain always a professional code of conduct.

The Board will provide further updates, as and when available, in accordance with the requirements of the Catalist Rules.
